Preface

Community Health Workers (CHWs) are frontline public health workers that act as a link between health care providers, social service providers, and health care consumers. CHWs build individual and community capacity by increasing health knowledge and self-sufficiency through a range of activities such as outreach, community education, informal counseling, social support, and advocacy.

Working in Community Health: Foundations for a Successful Career is written to prepare and educate community health workers for employment with the potential of a career ladder. This book provides specific knowledge required for effective employment skills, understanding basic anatomy and physiology of the most common chronic diseases, teaching how to access and understand health knowledge, as well as resume development and interview proficiency.

The book contains four sections. The first section contains Chapters 1, 2, 3, and 4 and includes the synopsis of public health as related to community health workers (CHWs). Chapter 1 provides an overview of the CHW profession. Chapter 2 covers the topic of adult learning and all levels of health literacy, including verbal, written, and numerical. The awareness and understanding of literacy are essential for CHWs in all aspects of their employment and practice. Chapter 3 presents and defines the concept of health equity and social determinants of health. Health equity explores the cultural disparities of access to health care. Social determinants build on the aspect of cultural diversity by exploring race, ethnicity, poverty, education, housing, job opportunities, and neighborhoods. Chapter 4 defines and explores social justice and advocacy, including both self-advocacy and community advocacy.

The second section includes Chapters 5, 6, and 7 and introduces causes of disease. Chapter 5 explores environmental sources of various diseases, such as mold, mildew, insects, rodents, smoke, chemicals, water, and air pollutants. Chapter 6 examines the human body systems and the interactions between systems. In addition, the types of chronic diseases are defined and explained, including heart disease, type 2 diabetes, and osteoporosis. Chapter 7 investigates infectious diseases with a discussion about routes, vectors, common contagious diseases, and vaccines.

The third section consists of Chapters 8, 9, and 10 and focuses on the aspects of aging. Chapter 8 begins this section by discussing client safety, including body mechanics, fall risks, balance, and types of abuse. Chapter 9 explores the effects of aging on the body systems as well as diet, exercise, vision, hearing, and dental issues. Chapter 10 explores quality of life, advance directives, and end-of-life planning from the perspective of the elderly client as well as their family and friends.

The fourth section focuses on the CHW profession. Chapter 11 discusses types of health insurance, and Chapter 12 covers healthcare facilities as well as employment opportunities at various facilities. Chapter 13 discusses ethics, rights, and responsibilities related to CHWs. Finally, Chapter 14 provides information about various CHW curriculum and certification as well as resume writing and interviewing skills.
